Funding Opportunities

Scholarships for Livestock and Poultry Farmers | FACT

FACT will award scholarships of up to \$400 for livestock and poultry farmers to attend educational events - including virtual events - to learn knowledge, skills and best practices related to humane animal management, business and farm finance, and/or value-added production processes.

Debt Forgiveness for BIPOC Farmers

Back in March, Congress designated \$4 billion in loan forgiveness for pandemic-affected, "socially disadvantaged" farmers under a provision of the American Rescue Plan Act. While these payments for BIPOC farmers have been held up, National Young Farmers Coalition is offering support to BIPOC farmers who have questions about eligibility for FSA debt relief and the effects of the payment freeze. Contact their Grassroots Manager at faith@youngfarmers.org. Also, the USDA is still asking potential beneficiaries to update their AD-2047 form in their local FSA office and return their signed letters of eligibility back to their local FSA office.

AGRI Livestock Investment Grant | Minnesota Department of Agriculture The AGRI Livestock Investment Grant encourages long-term industry development for Minnesota livestock farmers and ranchers by helping them improve, update, and modernize their livestock operation infrastructure and equipment. This grant program reimburses investments in buildings or facilities for the production of livestock or livestock products, development of pasture for use by livestock (lanes, watering systems, and fences), and equipment for livestock housing, confinement, feeding, and waste management. > Proposals must be received by November 17, 2021.

Applications to Help Cover Costs for Organic Certification | USDA

Organic producers and handlers can now apply for funds to assist with the cost of receiving or maintaining organic certification. This program provides cost-share assistance to producers and handlers of agricultural products for the costs of obtaining or maintaining organic certification under the USDA's National Organic Program. > Learn more and apply by November 1.

Farmer Rancher Grant | North Central SARE

North Central Region - Sustainable Agriculture Research and Education Program (NCR-SARE) Farmer Rancher Grant Call for Proposals is now open. Farmer Rancher grants are for ideas initiated by farmers and ranchers and are offered as individual grants (\$15,000 maximum) or team grants for two or more farmers/ranchers who are working together (\$30,000 maximum). NCR-SARE expects to fund about 40 projects in the twelve-state North Central Region with this call. **Proposals are due on December 2, 2021, at 4 p.m. CST**.

Choose Iowa Marketing and Promotion Grants | IDALS

Iowa Department of Agriculture and Land Stewardship is offering **Choose Iowa Marketing and Promotion grants** for Iowa producers. The grant program matches up to \$25,000 per project to help farmers, businesses and non-profits increase or diversify their agricultural product offerings. Applicants can use the Choose Iowa grants to try new processing, packaging and sales techniques that add value to the commodities that they produce. For example, a dairy farmer may invest in on-farm processing or packaging equipment to sell cheese to grocery stores and farmers markets. Grant funding can also be used for employee training and continuing education programs.
