## **Survey Open to Request Cost Share Acres for 2019**

With a new award from the NRCS's Conservation Innovation Grant, **PFI will be** 

**able to offer cost share on small grains harvested in 2019 and a following cover crop that includes legume species.** For details on the cost share eligibility and program requirements refer to <u>this flyer</u>. Because we were unable to give cost share to everyone who contacted us last year, we've changed the payment structure to pay \$25/acre on up to 100 acres of small grains plus a legume cover crop. This will allow PFI to **cost share 5,000 acres in 2019** across Illinois, Indiana, Iowa, Minnesota, Ohio and Wisconsin.

In order to be first in line to claim your cost share, you can start requesting acres now via this link. The survey will ask for your contact info, the number of acres and small grain you plan to plant and the legal land descriptions for the field(s). Completing this survey does not guarantee that you will get cost share, but it puts you in the official queue. Contracts will be issued on a first-come, first-serve basis.

# September 7 Shared Learning Call on Growing Cover Crop Seed in Iowa


