Are you intending to seed cover crops in fall 2024? Enrollment is open in our cover crop cost-share program, stackable with any publicly funded cost-share.

Payment rates are \$10 or \$15 per acre on an unlimited number of acres.

Participants must farm in <u>eligible</u>
counties in Iowa, Minnesota, Missouri,
Nebraska or South Dakota.
