#### FEE SCHEDULE

If you are the only person from your family or farm and register for  
grazing...pay \$120  
bio monitoring...pay \$75

For each additional member of your family or farm you register for  
grazing...add \$100  
bio monitoring...add \$70

If you attended Financial Planning or already registered for Grazing, take \$5 off of bio monitoring for each previous class.

**NOTE:** It pays to bring someone else from your family or farm!

\* Members of a family or farm must take the same course to be eligible for this discount.

**AND:** Fees cover lunch, snacks, and most materials. Optional Planned Grazing software (\$100, requires Excel 2007 or 2010) will be available from the instructor the first day of the course, payable in person.
